Spots will be decided on the morning of, depending on the number of vendors. **Setup and sales will start at 8 AM. Early setup is encouraged, as no vehicles are allowed on the park grass due to underground sprinklers.**

NON-REFUNDABLE REGISTRATION FEE IS \$20 for any general vendor that is a member of the Similkameen Country Chamber of Commerce. We are unable to provide tables or chairs, so you will have to bring everything you need for your own setup. If you require more space, there will be an additional cost. Only one business entity allowed per space. Preference will be given to locals and first registration paid.

NON-REFUNDABLE REGISTRATION FEE IS \$40 for any general vendor that is NOT a member of the Similkameen Country Chamber of Commerce. We are unable to provide tables or chairs, so you will have to bring everything you need for your own setup. If you require more space, there will be an additional cost. Only one business entity allowed per space. Preference will be given to locals and first registration paid.

NON-REFUNDABLE REGISTRATION FEE IS \$75 for any Hot Food Vendor or Food Truck that is a member of the Similkameen Country Chamber of Commerce. We are unable to provide tables or chairs, so you will need to provide everything required for your setup. If you require more space, there will be an additional cost. Only one business entity allowed per space. Preference will be given to locals and first registration paid. You will also require a Health Operating Permit given by your respective health authority.

NON-REFUNDABLE REGISTRATION FEE IS \$100 for any Hot Food Vendor or Food Truck that is NOT a member of the Similkameen Country Chamber of Commerce. We are unable to provide tables or chairs, so you will need to provide everything required for your setup. If you require more space, there will be an additional cost. Only one business entity allowed per space. Preference will be given to locals and first registration paid. You will also require a Health Operating Permit given by your respective health authority.
